Fourth International Conference on Islamophobia

Examining the Cultural and Geopolitical Dimensions of Islamophobia in Muslim Majority Countries

Concept Note

Since at least the 1970s, global political actors have instrumentalized Islamophobia as a tool to advance their geopolitical objectives and consolidate their hegemonic policies across the Muslim world. In this context, the geopolitics of Islamophobia refers not only to its political, economic, and geopolitical dimensions, but also to its functional use as part of various strategic imperatives and tools employed by regional and global powers to advance colonialist objectives, empire expansion, authoritarian and corrupt rule, or narrow self-interest. In addressing this phenomenon, the Center for Islam and Global Affairs (CIGA) at Istanbul Sabahattin Zaim University (IZU) convened three international conferences over the last several years to discuss this challenge and its destructive impact, not only on Muslim societies and minorities around the world, but also its influence on global politics and international relations.

CIGA's first International Conference on Islamophobia, was organized in 2018 and featured some of the most notable international experts and scholars on the topic. It explored the impact of Islamophobia on culture, society, politics, and international relations. In the second conference in 2019, CIGA brought together some of the most renowned speakers from around the world in order to examine Islamophobia's role in diverse intellectual, cultural, and regional contexts, and analyze its discourse and geopolitical impact. In 2021, CIGA's third international conference examined the utilization of Islamophobia in the different manifestations of the so-called Global War on Terror, twenty years after it was launched in the aftermath of the 9/11 attacks.

This year, CIGA, in cooperation with Prince Alwaleed Bin Talal Center for Muslim Christian Understanding at Georgetown University in Washington DC, USA, the University of Lahore in Pakistan, the Universiti Malay in Malaysia, and the International Islamic University in Islamabad, Pakistan will convene in March 2023 the Fourth International Conference on Islamophobia with a clear focus on the utilization and instrumentalization of Islamophobia, its devastating effects, and resulting long term impact on society and politics in Muslim majority countries, particularly in reference to recent times. The use of Islamophobia as a tool by different regimes and political actors in the past few years in Muslim majority countries has been rampant for largely legitimizing their despotic rule and authoritarian systems. It has also been used as means to delegitimize certain political opposition groups in these societies, particularly in the aftermath of the Arab Spring phenomena, since religion has been playing a prominent role not only as a source of empowerment and change for the peoples in various Muslim societies, but also as a powerful inspirational force within civil society institutions.



In this conference several topics related to the theme will be discussed. During the conference speakers will examine the roots and intellectual history of Islamophobia and anti-religion discourse in Muslim societies including in the Arab World, Türkiye, Iran, the Indian Subcontinent, and Southeast Asia. They will examine the impact of political, legal, cultural, and social factors, as well as the spread and proliferation of some social trends within Muslim societies such as atheism and anti-religious discourse, modernity, and secular thought, as well as gender issues. There will also be several speakers that will examine the role of authoritarian regimes and statesponsored religious scholars in promoting and instrumentalizing Islamophobia. In addition, several sessions will discuss several case studies from Muslim-Majority countries, and the role of colonialism, nationalism, and racism. In the final session, scholars will engage in an open discussion on strategies, policies, and actions needed in order to confront Islamophobia in Muslim majority countries. Finally, it must be noted that one of the major objectives of this conference is to bring together leading scholars in their respective fields in order to intellectually engage in thoughtful discussions on some of the major issues related to Islamophobia within Muslim majority societies, and to ultimately explore the range of appropriate responses. The panels will not only analyze these topics and present prescient assessments but will also attempt to present practical solutions to difficult challenges.
