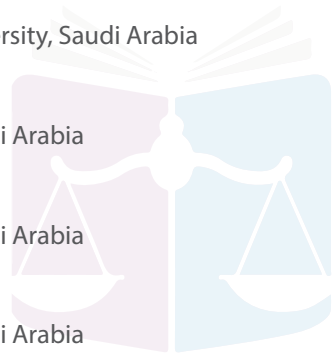

Keynote Speech I

**Sustainability, Transparency and Rule of Law
in EU Trade and Investment Agreements – Or:
What to expect when negotiating with the EU**

Abstract: The EU and its Member States are diversifying their international supply chains after the Russian attack on the Ukraine and declared China a systemic rival. The EU and its Member States are dependent on energy supply replacing their former dependency on Russian gas and oil exports, but also other raw materials. This development is one of the reasons why the EU has adopted a new trade and investment strategy, which deviates from the traditional approach taken by its Member States. In essence, the key words of the EU approach are sustainable development, transparency, rule of law and the protection of human rights. Those key points must be regarded in all agreements concluded by the EU or its Member States. One interesting question is whether third countries, including Saudi Arabia and other Middle Eastern countries, will accept those terms in their agreements with the EU or its Member States. If they do, the Middle East has the chance to learn from past mistakes of European countries in their trade and investment agreements. In investment protection policy, the old European “gold standard” has been subject to numerous criticisms, which the new EU approach intends to remedy. The trade sector nowadays will also have to consider supply chains and human rights standards. If the Middle East is open to this new approach, it may be able to not only avoid negative experiences but follow a modern trade and investment strategy instead.

ABOUT THE SPEAKER

Marc Bungenberg is Director of the Europa-Institut and a Professor of Public Law, European Law and Public International Law at Saarland University in Germany. He is a visiting professor at the University of Lausanne and member of the scientific advisory board to the International Investment Law Centre in Cologne.

Prof. Bungenberg received his doctorate in law from the University of Hannover and wrote his professorial thesis at the Friedrich-Schiller-University Jena. He holds an LL.M. from the University of Lausanne and his main fields of research are European law (Common Commercial Policy, public procurement and state aid law) and international economic law, particularly international investment and WTO law.

Keynote Speech II

Constitutional Supremacy, Constitutional Amendment and the Basic Structure Doctrine

Abstract: Constitution supremacy affirms that the Constitution is the highest law of the land and pursuant to the Westminster model of democracy, the three branches of government namely, the Legislature, Executive, and Judiciary, are required to function in accordance with the restriction set by the Constitution. The legislature can only make laws following the limit set by the Constitution and any laws which are inconsistent with the Constitution shall be declared void to the extent of the inconsistency. The Judiciary is the mechanism through which the Constitution's supremacy is safeguarded. The judge's oath of office has seen the emergence of the constitutional oath doctrine which basically placed the Judiciary as the guardian of the Constitution and is entrusted with the 'supreme policing authority' over other organs as well as high public offices in performing their constitutional role. It is the duty of the judiciary to assure that the laws were legislated in accordance with the Constitution and that all executive agencies administer the legislation according to the rule of law.

The constitutional supremacy does not mean that the constitution is so rigid and immutable. Rather, it is a 'living document' which is 'reviewable from time to time'. The power to amend the Constitution is vested with the legislature who can amend the Constitution in any way they think fit, provided that all the conditions precedent prescribed in the Constitution are adhere to strictly. While the basic structure doctrine prescribes that the Constitution contains certain basic features which cannot be altered, changed, or amended by the legislature. This would include matters such as supremacy of the Constitution, fundamental liberties, constitutional monarchy, federalism, the separation of powers of the three branches of Government, and independence of the Judiciary, among others. Having said the above, this paper discusses.

Having said the above, this paper will discuss the constitutional supremacy doctrine, the process and procedure for a constitutional amendment with special reference to the Malaysian Federal Constitution and the judicial power of the court to preserve, protect and defend the Constitution. Further, the paper will also discuss the consequences of an amendment to the constitution that alters or changes the basic structure of the constitution.

ABOUT THE SPEAKER

Ashgar Ali Ali Mohamed (Dato' Sri Dr) is a Professor at Ahmad Ibrahim Kulliyah of Laws, International Islamic University Malaysia (IIUM). He graduated with a Bachelor of Laws (LLB (Hons)) and Master of Comparative Laws (MCL) from IIUM, Master of Laws (LLM (Hons)) from the University of Auckland, New Zealand and Doctor of Philosophy (PhD) from the Graduate School of Management, University Putra Malaysia. He was admitted to the Malaysian Bar as an advocate and solicitor by the High Court of Malaya in 1992. His area of interest includes Employment Law, Constitutional law, Civil Litigation and Alternative Dispute Resolution. He has authored several books on the above subjects and published numerous articles both in the local and international journals/reports and further, presented papers on the abovementioned areas at various international and local conferences.

Abstract: The Middle East and international arbitration have a long history that stretches over many decades and thrives despite many twists and turns. Today, that relationship is even more important in light of the inextricable link between energy and sustainability, between dispute resolution and global governance, and between international lawyers and the rule of law. This keynote will survey that history and offer thoughts about what that history means for the future of international arbitration and its contributions to sustainability and world peace.

ABOUT THE SPEAKER

Dr. Catherine is a scholar of international arbitration and professional ethics at Bocconi University, with a dual appointment as Professor of Ethics, Regulation, and the Rule of Law at Queen Mary, University of London, where she is also Co-Director of the Institute for Ethics and Regulation.

Dr. Catherine is a Reporter for the American Law Institute's Restatement of the U.S. Law of International Commercial and Investor-State Arbitration. Among other appointments, she sits on the Board of Directors of the Lagos Court of Arbitration, the International Advisory Board of the Vienna International Arbitration Centre, the Geneva Center for International Dispute Settlement (CIDS) Academic Forum on ISDS, and the Oxford University Press Investment Claims Advisory Board. Dr. Catherine co-chaired the ICCA-Queen Mary Task Force on Third-Party Funding in International Arbitration, and she is the Founder and CEO of Arbitrator Intelligence, a global information aggregator and legal tech start-up that aims at improving arbitrator selection. She regularly engages in capacity-building activities to promote international dispute resolution and the rule of law in developing and emerging economies.

Title: Theoretical Framework and Analysis of Saudi Arabia New Companies Law 2022

The Saudi Cabinet of Ministers on 28th June 2022, approved the New Companies Law, and it was published in the official gazette on 4 July 2022 pursuant to Royal Decree No. (M/132) dated 01/12/1443H (the “New Law”). This new Law came into effect on 1 January 2023, replacing the previous Companies Law issued in 2015 and the Law of Professional Companies issued in 2019. The New Law largely unified KSA rules related to commercial companies, professional, and non-profit companies under one law. This New Law removes restrictions on company names and now allows for greater flexibility on naming a company. This research analyses the new law in the light of the sharia advanced international practices, and advanced regulations in this field. The New Law, which is in line with the Kingdom’s 2030 Vision, introduces new changes, allows greater flexibility, safeguards businesses’ interests, empowers the private sector and follows the best international practices. The New Law introduces several new changes to the rules of establishing and the governance of Joint Stock Companies, also introduces a new type of entity, being the Simplified Joint Stock Companies. The methodology adopted in this research is purely “doctrinal”. To pursue the study researcher relied on various sources of information, statutory provisions of the new law, articles published in various journals or websites, commentaries given by lawyers, experts, academicians, and law firms.

This study aims to ascertain whether the outbreak of Covid-19 pandemic threatens the efficiency and growth trajectory of the banking sector from the perspective of Nigerian publicly quoted banks. To achieve the stated aim, data were obtained from the annual reports of 13 publicly quoted banks in Nigeria, covering five quarters prior and five quarters after the nationwide lockdown due to the Covid-19. The data obtained were mainly analysed using data envelopment analysis (DEA) and latent growth curve modeling (LGCM). The DEA results show an upward trend in the average scores of technical efficiency, pure technical efficiency, and scale efficiency in both periods. The LGCM results reveal that there is statistically insignificant difference in banks' growth trajectory (rate of change) in both periods. Overall, our analyses suggest that the outbreak of Covid-19 does not threaten the efficiency and growth trajectory of the banking sector. While we have revealed that the emergence of Covid-19 did not threaten the efficiency and growth trajectory of the banking sector, the insignificant difference between the pre and post nationwide lockdown suggests that there is an insignificant improvement in the efficiency and growth trajectory of the banking sector during the post nationwide lockdown period.
