Important hadith mentions that Allah (SWT) loves the youths who try to avoid their illegal urges of active life. Youths are like precious raw stones. They must always be brushed so that they shine. They should be encouraged so that their mindsets are always active and ready to engage.

They must also be supplicating Doa from Allah (SWT). They will try to fulfil the desire or the will of their parents if the latter can make Doas and show them how much they care. They will also want their parents to know that they are returning the favour in the same way.

Good and bad indeed lie in the management of Allah (SWT). However, if the parents fulfil their responsibilities as mentioned above, it is much better than not being able to do anything at all. There will be no changes at all if they sit back and watch it. Allah (SWT) will only help to change if they put efforts on their own.

Allah said in this regard: "Verily, Allah will not change the (good) condition of a people as long as they do not change their state (of goodness) themselves (by committing sins and by being ungrateful and disobedient to Allah)."

1.7. Conclusion

Having good children in one family does not serve the purpose of producing good leaders in a nation, and youths from the entire society must also be productive. This idea must be instilled in the mindsets of every parent and the youth. Thus, they are not only responsible for making themselves industrious, but their siblings, relatives, and friends also belong to the same category.

Love and care of parents make their worries cool and chill. and the children will trust the parents more than their friends. Abu Huraira reported:

The Prophet, peace, and blessings be upon him said "A man is upon the religion of his best friend, so let one of you look at whom he befriends."

This Hadith indicated how important having a good friend who must be honest, righteous, and trustworthy. If they are not trusted and comprise contaminating habits and ideas to the youth, then it is parents who have to answer in this world as well as the hereafter.

Eighth, shaping future leadership programs involved both parties of parents and the youths, as the latter are also important to participate in its implementation by following the guidance of the parents as well as the practices of the Prophet, PBUH.

The Prophet (PBUH) said, "The example of a good companion (who sits with you) in comparison with a bad one, is like that of the musk seller and the blacksmith's bellows (or furnace); from the first you would either buy musk or enjoy its good smell while the bellows would either burn your clothes or your house, or you get a bad, nasty smell thereof."

Therefore, knowing how to choose good friends is extremely significant for the future of the youths, as this selection will determine the success of the youths. Parents should also spend time finding out whom their children are befriending.

interest of the family. Mother and father must support each other if they wish to create a peaceful family life. One must support another's decisions though sometimes it is difficult. In this way, there is less likelihood of going astray because they have already been introduced to excellent leaders to follow. Thus, they are going to compare whomever they meet in their neighbourhood with their heroes such as the Prophet, PBUH, or his companions. They are less prone to being misguided because they know and understand more than other children who do not have such experience. They will be able to lead their friends to the right path. This is the way the children from the beginning, can be expected to become good leaders in the future.

Sixth, Parents should also try to become good Muslims who is most preferred by their children. They must learn Islam and practise it according to the proper teachings of Islam. They must be very familiar with the commandments of Allah, SWT, and the sunnah of The Prophet Muhammad, PBUH. They must also be consistently performing the Salat, prayers, the fasting of Ramadan, Zakat payment and Hajj activities, etc. Consequently, their children will also become true Muslims just like them. Third, parents must make known to their children about their love, solidarity, and care for each other. There are many tragic consequences of a broken family and abandoned children in the media and the news which can be sources of lessons for both parents and the youths.

Fourth, A crucial point which should be noted that the cognitive power of people is never the same, even between father and mother. Both parents think differently. It is not easy to unite when the two different minds come together as one family. Thus, they must build an integrated approach among themselves before raising a child. They must understand that their different mindsets in common factors could negatively influence their children. It is almost impossible to bring the two different approaches together. However, both should strive to respect each other's differences and set up a common goal for the best

intellectual capacity. Therefore, it is known that "seeking knowledge is a compulsory task" in Islamic perspective.

The youths who grow up in the disconcerted families with social problems are bound to face many challenges in their lives. The young minds cannot adjust social ills in their environments. Their exclusive character plays a crucial role in their social circles. They will neither discriminate people nor push people into difficulties. It is believed that the provision of discipline and education plays a crucial role in making them such valuable people. They are more likely to be elevated to an unprecedented level in their social circles because of useful knowledge and their

desire the best future for their children, and they want them to be successful in their life. Thus, they put a seemingly reasonable restriction on their children, which might result adversely.

Consequently, both the parents and the youths fail to identify the thoughts and understandings of each other, affecting the well-being of both, and end up with displeasure and dissatisfaction. It is easier to mould the wax when it is soft but difficult to shape it when it solidifies, and the only result could be the breakage of wax if it is a late moulding at the far later stage. Therefore, it is crucial to have a series of discussions on this topic and disseminate the relevant information collected and experienced throughout this research, which has been concentrated for the sake of the young people.

The teenagers of today's world must realize the significance and usefulness of the life of youth. Teenagers, who have had a chance to live with the guidance and discipline of their excellent parents, could be considered very lucky because a solid foundation was laid for their future.

For those parents who do not have the same circumstance or capability to discipline their children often end up frustrated because the lives of their children do not live up to their expectations due to depraved incidences and immoral influences. Nothing could be done for those parents except the sadness and frustration encountered at that stage. In order to avoid such a painful experience and uncontrollable situation, parents should study all kinds of disciplinary measures setting in advance against such unwanted circumstances.

Multi-disciplinary measures for youth awareness programme includes the study of psychological nature of youths, their characteristics, consequences of their good behaviours and, at the same time, negative aspects of anti-social activities, environmental influences, reasons of social illness, and their solutions. With such knowledge and information, parents can attain a rare chance of disciplining their children as well as assist those parents who need such guidance and supervision for their children. Moreover, it is inevitable that such knowledge can create a blessed and better future for one's family circle and that of society. Therefore, it is crucial first to study the nature of the youths.

Experts in child development define the life of youth as a period between the ages of fourteen to twenty-two. Psychological and physical events of childhood could be observed during this period, regardless of a girl or a boy, gender difference. Once the youth reach the age of adolescent, they start to question and explore why they were born, what do they want to be and so on. They will also try to find answers to these questions during that time.

Psychologists consider this period as the most challenging for the youths as they are going through the period of "identity crisis", while figuring out answers to their

discussed. The grievous consequences of children away from parental care during their school transition period of young lives are to be explained.

Firstly, the responsibilities of parents explored, and the positive approaches parents should have impacted on children, fulfilling parental duties are elaborated. Thirdly, a step-by-step approach to the development of well-mannered children discussed. Parents are also informed with the activities they can carry out and those which they need to avoid. It was encouraged that parents work on their characters and become role models first before their children could be taught what the right and the wrong, and the good and the bad are. Moreover, parents with busy schedules are also encouraged to show a caring attitude towards their children. Parents are recommended to earn respect and trust through their actions, followed by teaching the children the beneficial knowledge. Furthermore, parents are informed about the adolescent life that the children go through. The nature of the adolescents and the ways to handle them when they go astray are discussed.

1.2. Nature of the youths

Youths are future leaders of nations as they are going to take them in the right direction with multi-dimensional means, ways, and different developmental approaches. Thus, they must be shaped to be good leaders with careful, systematic tactics, procedures, and schedules. Youth development could be considered as a much-needed task in this rapidly developing world not only with the advancement of globalization and information technology but also the overwhelming threat of drugs, weapons, and alcoholism. Today, the teenagers are facing different challenges and adversities which have been beyond their control. At the same time, parents are witnessing their children involved in the dangers of superfluous moral deterioration, substance abuse, immoral acts, illegal sexual practices, increase in criminal activities, outstanding unemployment, and failure in educational pursuit.
