While AI tools offer benefits in improving diagnostic accuracy, streamlining literature reviews, and even assisting in manuscript drafting, the AI also raise critical concerns about academic integrity, authorship ethics, and data privacy (4, 5). IJCS acknowledges the dual-edged nature of AI and is committed to developing clear editorial policies that balance innovation with integrity, ensuring the journal remains a credible voice in care scholarship, either nursing or health related sciences (6).

Looking ahead, IJCS is dedicated to nurturing the next generation of nursing and health related scholars, researchers, and educators. The journal hopes to provide a supportive platform for not only early-career researchers, but also anyone with similar notion to share their findings, engage in interdisciplinary dialogue, and contribute to global health conversations (7). This inclusive approach aims not only to strengthen the quality and diversity of submissions but also to cultivate a dynamic academic community grounded in knowledge, compassion, and ethical practice.

As IJCS charts its path toward broader indexation, the focus will remain on enhancing citation quality, increasing international authorship, and improving editorial transparency (8). Current initiatives include expanding the journal's scope, fostering global collaborations, and elevating its academic profile through strategic dissemination and digital engagement.

In conclusion, the journey of IJCS from its humble beginnings to becoming a MyCite-indexed journal is a testament to perseverance, academic integrity, and vision. As the journal strives toward higher indexing,
