Chapter 8

Secular Humanism and The Islamic Conception of Human Being (*Insān*)

Introduction and Background

The term Secular Humanism is alternatively known as Humanism and it is often spelled with a capital 'H' to distinguish it from other forms of humanism. There is no universal doctrine or tenet for all Humanists to adhere to but various declarations and statements have been issued in an attempt to unify the Humanist identity. Nonetheless, member organizations of its umbrella organization the International Humanist and Ethical Union (IHEU)¹ are required by law to accept the *Minimum Statement on Humanism* which is stated below.²
