Abstract The demand for neutrality and impartiality in the modern study of religions has

challenged the role of theology in defending religious truth. As post-modernity emerged, its philosophy sought to deconstruct modern philosophy and everything under its shell. The post-modern philosophy is sceptical against the notion of objectivity and favour for relativism.
