Notionally, however, it is divisible into three segments, namely, the legal and regulatory framework governing Islamic banking in Malaysia, the essential features of Islamic banking products such as bai' bithaman ajil and bai' al-'inah, murabahah and tawarruq, ijarah, istisna, kafalah and rahn and the recovery process aspect applicable for disputes between the bank and the customer. Be that as it may, the special feature of the book lies in the fact that, for every such discussion undertaken via the chapters, commentaries of the relevant case law authorities were provided by the authors. As is discernible from the comments made, the personal opinions of the authors and the judicial pronouncements of the judges, as per the issues deliberated in the judgments, did not necessarily coincide. It bears no repetition that the diversity of views proffered is enriching. and contributes to the existing literature on the legalities of Islamic banking practices in this country.

The publisher and the authors have no qualm that the book will appeal to readers from various backgrounds. Students, researchers, academicians, bankers and members of the judicial and legal fraternities all stand poised to gain in more ways than one from this book.
