The World Today


- Capitalism, Globalization and ICT dominated Era

Globalization & Healthcare Challenges

Globalization?

- Created a world without border
- The reduction of barriers to the movement and transfer of ideas, goods, investment, technology and people across national boundary
- A process of interaction and integration among people, companies, and governments of different nations.

What is Health care?

- It refers to a state of adequate physical, mental, and social well being, and not just the absence of disease or weakness.
- Health is based on the concept that one is in perfect condition physically, mentally, emotionally, socially, and spiritually.

Impacts of Globalization on Heath care

- Globalization causing profound and complex changes in our society by bringing in new opportunities and risks.
- It can be disadvantageous as well for example the spread of disease is a lot easier in our current borderless and interconnected world.

Impacts of Globalization (cont...)

International trade of pharmaceuticals

- •Globalization influencing healthcare financing and service provisions which means health is regulated and marketed.
- High price for medicines and drugs to treat HIV/AIDS infections
- Domination of merging leading healthcare companies

Global tobacco and alcohol markets

- •Tobacco produces 4 million deaths a year, and this figure may reach 10 million by the year 2030. (McKee et al., 2001)
- Targets people in poorer nations
- •It causes a high rate of lung cancer, liver cirrhosis, and alcoholism

Environmental contamination

- The rise of the global environment threat causes many environmental threats including ozone depletion or greenhouse effects hence health implications.
- Caused by economic growth and high demand of commodities
- Causes skin cancer, asthma etc.

Impacts of Globalization (cont...)

Migrant workers

- Globalization create more job opportunity across the national boundary but migrant workers might carry diseases with them and introduce it to the new land they enter.
- Leprosy, tuberculosis, diphtheria, and HIV/AIDS

Global inequality

- Globalization promote privatization, which demonstrates harmful effects on the health of poor and poor countries
- Sufferers go though poverty, hunger, death, and disease.

Impacts of Globalization (cont...)

Cross border flows talents

- Causes brain drain for poorer countries.
- High numbers of medic students from developing countries study in developed countries and finally settle down there

Change of lifestyle

 The adoption of unhealthy lifestyles and diets (e.g. fast food) creates further health risks including cardiovascular diseases, obesity, and certain forms of cancer. and reconfiguration of existing health challenges

Migration & Military conflict

 Military conflict and migration became the biggest contributor to the spread of the health problem

 Lack of transparency and accountability in healthcare service delivery

 Globalization promote codification and commercialization of R&D and medical research output

Who are Professionals?


- The term "professional" has become associated with great prestige.
- Professionals are those who possess special skill, competence, organization, and altruism, etc.
- They control practitioner-client relationships and the functional relevance of professionals' activities.
- Those who exercise <u>an institutionalized</u> <u>form of control</u>, and the content of work through professional organization.

Who are Professionals? (Cont...)

- Members of those occupations that have <u>a high degree of autonomy and</u> <u>ensure a privileged place</u> in the economy.
- A group of individual practitioners who are protected by their specific "professionalism" i.e. continuous improvement of their expertise standard of practice to make their service functionally relevant (Bledstein, 1976; Freidson, 1994, 2001).

- Logic of consequentiality

LOGIC OF APPROPRIATENESS

- What kind of a situation is this?
- Who am I?
- How appropriate are different actions for me in this situation?
- Do what is most appropriate.

LOGIC OF CONSEQUENTIALITY

- What are my alternatives?
- What are my values?
- What are the consequences of alternatives for my values?
- Choose the alternative that has the best consequences.

THE LOGIC OF HOLINESS AND GODLINESS

As Allah mentioned in Surah an-Nahl verse 90:

"Verily, Allah commands, Adl (fairness, equity, justice), Ihsaan (excellence in servitude to Allah, benevolence towards people, graciousness in dealings), and giving to those close to you, while He forbids Fahshaa (indecency, licentiousness, immorality), Munkar (unaccepted behaviour, not fulfilling ones obligations), and Baghy (exploiting and violating others rights, abuse of authority). He admonishes you so you heed the advice.

LOGIC OF HOLINESS/ GODLINESS

- Personal, material and spiritual consideration
- Responsiveness to client needs and demands
- Diligence in work and competence
- Co-operation rather than competition
- Consultation as a process
- Human oriented rather than profits oriented
- Human dignity, freedom and social equity
