Background: Foundation of Islamic Finance Conference Series, 2006-Ongoing

This note is given to all those who have received an acceptance letter to present a paper at the 10th FIFC hosted by the Sunway University in Malaysia on Thursday 28th November 2019, after the peer-reviewed decision is made for accepting papers. The 2019 meeting was jointly managed by delegates from (i) International Islamic University Malaysia (ii) Cardiff University, United Kingdom (iii) INCEIF, Malaysia. The Foundation of Islamic Finance series started with a large grant by the Australian Research Council (ARC) in 2006 to the original team at The University of Melbourne (Prof Abdullah Saeed) and Monash University (Distinguished Prof Mohamed Ariff & Prof Michael Skully) to create authentic literature for the then emerging sub-discipline in Finance usually referred to today as Islamic Finance or Participatory Finance.

This conference series have been held since 2006, and the 2019 meeting in Malaysia is the tenth occasion. The previous conference venues have been in Melbourne, Malaysia, United Arab Emirates and United Kingdom. All papers are peer reviewed by a panel selected from a list of established researchers in this emerging field of study. The review process once completed the papers are ranked from 1-5 to provide feedback to a Professional Committee for best paper awards. Papers receiving 4-5 points in a scale 1-5 are then selected and ranked by a Committee to select best papers with opportunity for publishing in a reputed journal and will receive award certificates. Those selected paper would be reviewed and edited journals will decide to publish those that pass the editorial review process. Over the last 10 years, we have also published several books on Islamic Finance by two leading UK and USA based publishing houses.

To-date about dozen papers have benefitted from such rigorous review-and-publish process since 2008. Selected journals (for example Elsevier and John Wiley in 2016) was planned to select papers for publication decision. In addition, the conference has an arrangement with a leading publisher to publish a book on a topic, with established scholars invited to present their study as chapters at the conference as well. For 2019 meeting, a 10-chapter book was planned: this item is still a work-in-progress with a potential publication date of 2021. As a result of such efforts during all previous events, several books have been published on banking, risk management, *sukuk* bonds and wealth management as the titles of the books. Book-publication by reputed publishing houses and best papers in journals are two ways in which the organizers have helped to establish valid literature for this new literature sub-discipline in finance.

Few words about the host, Sunway University is the leading not- for-profit university in Malaysia Its 2019 QS ranking is 751-800 in the world and 232 in Asia. We urge the deans and HODs to take these factors to consider funding your scholars to attend this conference as a scholarly effort by your staff to build a literature for Islamic Finance in this and future conference. The 2020 meeting is planned to be hosted by Cardiff University, UK, as be the 11th Foundation of Islamic Finance Conference.
