The world has been changed by Information and Communication Technology (ICT), and many factors including new opportunities, fast-growing business, technological changes, and challenges have forced every part of the world to produce self-regulating and pre-found skilled oriented individuals. Driven by this compulsion the education institutions (EI) around the globe are integrating ICT tools and utilizing the latest technologies in order to provide quality education to their citizens. In this regard Ministry of Education (MOE) Kuwait has launched many plans and invested a lot in the implementation of technology in EIs. EIs mainly consists of Universities.
