Many reference are made to the situation of refugee in other countries without linking it to Malaysian condition. Furthermore, the author refers to very few sources on Malaysian refugees while there are many relevant sources and materials available. More data, including cases and international jurisprudence, discussion and analysis are need to improve the paper. Please proofread the paper for grammatical errors and choice of words.
