

# Domestic violence at crisis level months after lockdown

PETALING JAYA: Newly-wed 'Nellie' jumped from the balcony of her first floor flat at 3.30am to escape her abusive husband, one week into their marriage.

The 21-year-old emotionally and physically battered bride required surgery, having suffered multiple fractures on four toes in the fall.

She was forced by her family into an arranged marriage on March 14, four days before the movement control order (MCO) was enforced in Malaysia because of the Covid-19 outbreak.

On the first day of the MCO, her husband began beating her. He threatened to hunt 'Nellie' and kill her if she tried to flee.

'Nellie' was recently discharged from the hospital and is at a Women's Aid Organisation (WAO) shelter where she is being assisted with case management.

The story of 'Nellie' paints a bleak picture of life for women for whom the lockdown of fear and abuse has intensified.

KUALA LUMPUR, Aug 25 — While many women's NGOs claimed that Malaysia saw a rise in domestic violence cases during the movement control order (MCO), the federal police said their statistics showed otherwise.

Bukit Aman's Sexual, Women and Child Investigations Division's (D11) analysis showed a 20 per cent decrease in cases overall.

Its principal assistant director ACP Siti Kamsiah Hassan, during a special interview with *Malay Mail* recently, said that her department's study found instead a rise in the number of parents being abused by their children during the first three months of the MCO.

"Before the MCO came into effect, most abuse cases reported stemmed from husbands of working wives — with most suspecting their wives of having an affair when they are at work or out independently.

"During the MCO, this somewhat changed because they were mostly homebound and the type of activities in the household changed. There was no movement for the women and therefore no time for husbands to accuse their wives of anything."

THE number of marriages in 2019 decreased by 1.2 per cent to 203,821 as compared to 206,352 in 2018, the Marriage and Divorce Statistics, Malaysia, 2020 report revealed today.

The report, which presents the statistics on marriage and divorce for 2018 and 2019 by demographic characteristics at national, state and administrative district levels, also revealed that the number of divorces had increased by 12 per cent to 56,975 last year from 50,862 in 2018.

Commenting on the publication, Chief Statistician Datuk Seri Dr Mohd Uzir Mahidin said in tandem with the decline in the number of marriages, general marriage rate for grooms declined from 50.7 to 50.1 per thousand population of unmarried males aged 18 years and above.

A similar trend was also recorded for brides, where a decline from 47.0 to 46.2 per thousand population of unmarried females aged 16 years and over was observed, he said in a statement.

Mohd Uzir said the general divorce rate for males increased to 7.2 per thousand population from 6.5 of married males aged 18 years and over, with similar trend was also reported for females, increased from 7.0 to 7.7 per thousand population of married females aged 16 years and above.

"The median age of grooms remained at 28 years. The median age for brides increased from 26 years (2018) to 27 years (2019)," he said.

Mohd Uzir said the increase in the median age of brides was also attributed to the average age of mother at first birth that rose 0.1 years from 27.9 in 2018 to 27.0 years in 2019.

MUAR, Nov 8 — The Women, Family and Community Development Ministry (KPWKM) has received a total of 1,929 complaints on domestic violence (KRT) since the Movement Control Order (MCO) was implemented on March 18 this year.

Its minister, Datuk Seri Rina Mohd Harun said Selangor recorded the highest number of cases, at 375, followed by Johor with 264 cases.

She said the complaints were received through the Talian Kasih at 15999 and most of them involved physical and/or emotional and sexual violence.

"That is why in Budget 2021, we provide a Local Social Support Centre to provide protection to victims of domestic violence, with the pilot projects to be carried out in Johor and Selangor," she told the media after visiting the Southern Zone Supply Depot in Parit Keroma, here, today.

In the tabling of Budget 2021 last Friday, the government announced an allocation of RM21 million for the setting up of local social support centres to address the issue of domestic violence.

The centres, which will be run in collaboration with non-governmental organisations (NGOs), will provide social protection and moral support to women who are victims of domestic violence,


