Meaning of wasatiyyah

- Literally: middle, center, heart
- Technically:

"Thus we have made you a just (balanced/the best) ummah that you be witnesses over mankind and the Messenger (Muhammad s.a.w) be witness over you..." al-Baqarah: 143

Meaning of wasatiyyah

• balance (*tawazun*) between two opposite sides; to provide each side according to its scope/ambit. to give each side according its right without extreme/exceeding the limit and shortening/decreasing.

- justice (al-'adl)
- the best (al-khiyar/al-jawad)

Manifestation of *wassatiyyah* in the field of Ibadah

Concession

- dropping the responsibilities: a woman who is in menstrual period, she is not obliged to perform prayer and she does not have to replace the missed prayer.
- reducing responsibilities: shortening the prayer.
- bringing forward an obligation to a future date: fasting for the traveller and sick person.
- changing the form of obligation: prayer

Manifestation of *wassatiyyah* in the field of Islamic Family law (*munakahat*)

- Mutual Rights and Responsibilities of Spouse:
- maintenance.

Manifestation of *wassatiyyah* in the field of Islamic law of Transaction (*Mu'amalat*)

- moratorium: payment of debt.
- legality of forward sale (bay' al-salam), manufacturing contract (istisna'), leasing (ijarah).

Manifestation of *wassatiyyah* in the field of Islamic Criminal law (*Jinayat*)

• Imposition of punishment:

"Set aside the execution of *hudud* punishments in cases of doubt (*shubhah*)."

Manifestation of *wassatiyyah* in the field of Islamic law on international relations (*al-siyar*)

- balanced legal principles on jihad.
- The verses must be read as a whole, taking into consideration the causes of the revelation and the context in which the verses were revealed.
- It is not proper to refer to just part of a verse
 e.g. "And slay them wherever you catch them"
 (Qur'an, 2:191 in part),

Islamic law on international relations (*al-siyar*)

disconnecting it from the immediately preceding verse "Fight in the cause of Allah those who fight you, but do not transgress limits; for Allah loves not transgressors" (Qur'an, 2:190) which provides the cause of fighting, namely: existence of aggression.
