Language editing is the sole responsibility of the author.

Subsidiary Rights and Compensation: It is understood that you will receive no monetary compensation from the University for the assignment of copyright and publication of the Contribution; from any fees that may be received from licenses to reprint the Contribution in readers, anthologies, textbooks, or the like; or from any fees that may be collected for other licenses granted for the use of your Contribution.

Royalty: The University will pay royalty only in kind. The University will provide copies of published contribution equivalent to 10% of the total sales.
